Supervisor Stubbs spoke of a meeting she and Supervisor Kilmer had with the neighbors. D. Archer and M.Clarke attended the meeting along with 22 residents and Josh from City Parks. Concerns were raised regarding noise, traffic and hours of operation.

Other topics included:

- Stormwater was an issue.
- AEC is not in the City of Madison, therefore, it does not abide by sound code
- Signs up after events and had been inconsistent

A suggestion was made to put a bus terminal there or a multi-model station. This would be great for economic development and environment. Consider a different bus entrance.

Discussion ensued regarding how redevelopment and the neighborhood could co-exist.

T. DeChant noted that the RFP for master planning include approaches to engage the neighborhood and mitigate the impact of redevelopment.

Sports events can bring in considerable direct spending.

John Nolen Drive is a grand entrance into the City of Madison. This is a once in a lifetime opportunity to define the corridor.

A motion was made by SCHMIDT, seconded by CRAIN, that the Alliant Energy Center Comprehensive Master Plan Oversight Committee recommend to the Public Works and Transportation Committee and the Personnel and Finance Committee that Dane County proceed this fall to retain a consultant to complete a master plan for the Alliant Energy Center 164 acre campus using the Vandewalle vision and implementation framework as a basis for the RFP process be approved. The motion carried by a voice vote.

1. Discussion and action on recommendations regarding next steps

DeChant asked, who will draft the RFP? Corrigan stated that the County Board can reference the vision statement to guide the RFP.

Becker asked, "Will the oversight committee have involvement in choosing the consultant? S. Corrigan said that is the intent.

Stubbs stated that the community component should be part of the RFP. Make sure concerns are articulated. She also said that the final document should include comments. Corrigan noted that the documents reference continued community engagement.

Clarke discussed how Oklahoma City invested in a niche market and now gets all paddle sports.

R. Crain spoke of development of facilities and what that can mean. Rockford has a community facility Monday through Friday, then does tournaments on weekends. The weekends help fund the community options for the other days.
