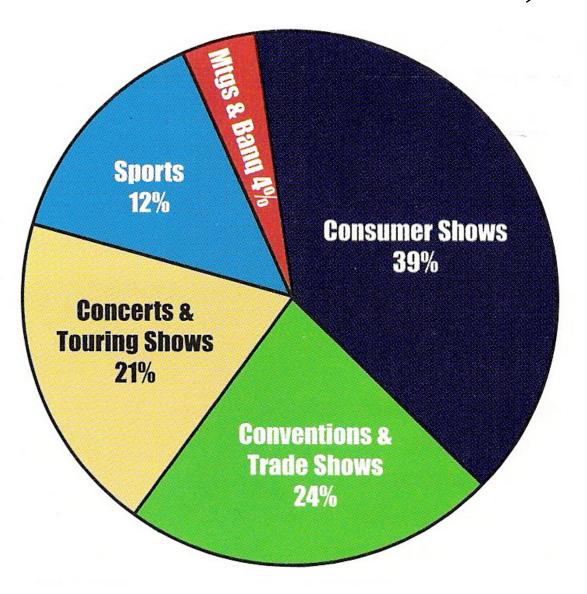


What is AEC

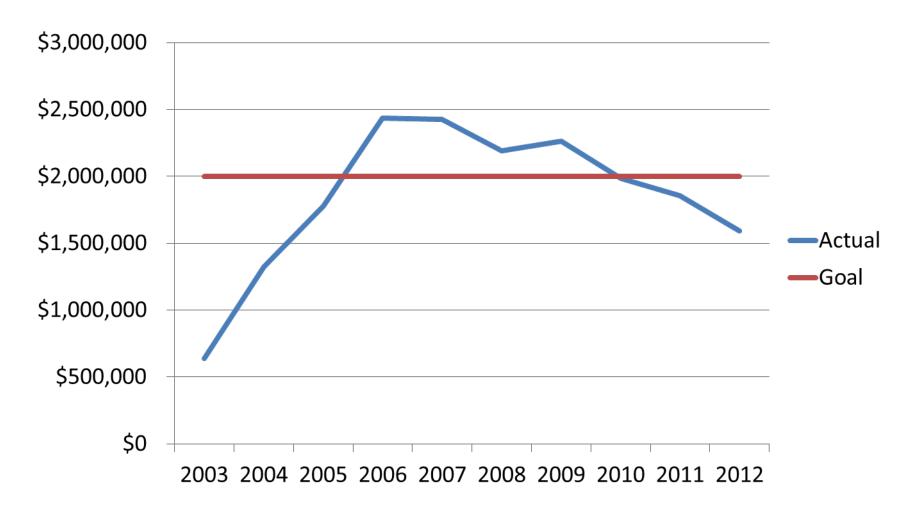
